3. Please note if ECO hours exceeds the original amount quoted, additional fees to be billed as per the original quotation.
4. Payment to be made in advance by cash/cheque/direct deposit into relevant account or internet transfer.
5. Refundable holding cheques for damage/cleaning costs will only be refunded within 3 weeks of completion of shoot.
6. Applicant must ensure that information is accurate and that relevant support documents are complete.
7. The onus lies with the Production House to ensure that they are adequately insured. The areas under the control of the relevant landowner are used entirely at your own risk. Neither the land owner or Peninsula Permits can be held liable for any claims, accidents, injuries or loss etc arising from such use.
8. A 20% cancellation fee, of the full permit fee quoted, is applicable on all cancelled permits due to any circumstances.
